# Design Standards No. 1 Roofing Materials

Pursuant to Article V, Section 5.05 of the Declaration of Covenants, Restrictions and Easements for River Park Place, recorded on January 10, 2006 as Instrument No. D206008307 in the Official Public Records of Tarrant County, Texas (the "Declaration"), the Architectural Control Committee (the "ACC") is authorized to adopt, publish, and promulgate Design Standards which shall be enforceable as restrictive covenants which run with the land.

Therefore, pursuant to the Declaration, the ACC does hereby publish and promulgate the following Design Standards:

The ACC committee has approved the following roof standards and materials for use within the River Park Place subdivision.

- 1. Minimum roof pitch shall be 6 to 12.
- 2. Minimum of a 20 year rated shingle with weight equal to 240 pounds or more per square.
- 3. Composite architectural dimensional shingle in weathered-wood, brown tone.
- 4. All equipment or improvements located on the roof shall be screened from view on all four (4) sides.
- 5. The following materials are prohibited: metal or aluminum, tile, and wood.
- 6. The pre-approved roofing material is
  - a. Brand: CertainTeed
  - b. Series: Landmark
  - c. Color: weathered brown
- 7. Any grade of the Landmark series in weathered-brown is pre-approved.
- 8. Any roof material or shingle that is outside the Certain Teed, Landmark series line is not pre-approved and must be submitted for approval through the ACC process.
- 9. Existing roofing systems with sections of decorative, accent metal are permitted. New installations of decorative, accent metal must be submitted for approval through the ACC process.

The ACC has approved this Design Standards to be effective upon its publication and promulgation.
